SOLUZIONE ST is recommended for pre-treatment of wall structures, brickwork, wood and plastic and also for the restoration of infested surfaces; it can be applied to the surface to be treated with a brush, roller or by spraying; once dry, remove any dust with a brush or cloth in order to eliminate any residues of spores, algae etc. If necessary, apply a second coat.

The product should be stored in a cool dry place, in the original well-sealed containers. It is stable for at least 12 months providing it is stored in a place where the temperature is not below +5°C or above +35°C.
